## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 2, 2018 (“Release”), is made by JPMorgan Chase Bank, N.A., in its capacity as collateral agent (“Priority Collateral Trustee”), in favor of 1780, LLC, a Delaware limited liability company, Camp Lake James, LLC, a Delaware limited liability company, Old Wildlife Club, LLC, a Delaware limited liability company, Crescent Communities, LLC, a Georgia limited liability company, and LandMar Group, LLC, a Delaware limited liability company, (each a “Pledgor” and collectively, the “Pledgors”).

**WHEREAS**, pursuant to that certain First Lien Pledge and Security Agreement dated as of October 14, 2016 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Pledgors, Priority Collateral Trustee, and others party thereto and the Trademark Security Agreement dated as of October 14, 2016 (“Trademark Security Agreement”) by and among the Pledgors and Priority Collateral Trustee, each Pledgor granted to the Priority Collateral Trustee for the ratable benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in and to the Trademark Collateral; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on October 14, 2016 at Reel 5900 Frame 0307.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Priority Collateral Trustee, on behalf of the Secured Parties, and Pledgors agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Priority Collateral Trustee, on behalf of the Secured Parties, hereby, without representation or warranty of any kind:

(a) terminates the Trademark Security Agreement;


(b) terminates, cancels, forever discharges, and releases the lien on and security interest in and to all right, title, and interest in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(c) authorizes the recordation of this Release with the USPTO at Pledgors’ sole cost and expense.

**SECTION 3. Further Assurances.** Priority Collateral Trustee, at Pledgors’ sole cost and expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably requested by Pledgors and as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Priority Collateral Trustee will, at Pledgors’ sole cost and expense and at Pledgors’ reasonable request, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

**IN WITNESS WHEREOF**, the Priority Collateral Trustee, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
