**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of May 9, 2018, and made by **NORTHWESTERN MUTUAL INVESTMENT MANAGEMENT COMPANY, LLC**, a Delaware limited liability company, as Administrative Agent ("Grantee") to **BAKEMARK USA LLC**, a Delaware limited liability company ("Grantor").

WHEREAS, pursuant to that certain Second Lien Trademark Security Agreement dated as of August 16, 2017 made by Grantor in favor of Grantee (the "Security Agreement"), the Grantor granted to the Grantee, among other collateral as set forth therein, a security interest in all of the Grantor's right, title and interest in, to and under the United States trademarks registrations and applications listed on the attached Schedule A, including any goodwill of the business connected with the use of, and symbolized by the trademarks (the "Trademarks");

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 16, 2017, at Reel 6128 and Frame 0903; and

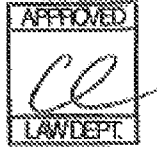
WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged Grantee hereby states as follows:

1. Definitions. All terms not herein defined, have the meanings set forth in the Security Agreement referenced above.
2. Governing Law. This Notice of Release of Security Interest in Trademarks shall be governed by and construed and interpreted in accordance with the laws of the State of New York.
3. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges any security interest in and lien upon the Trademarks, and reassigns, transfers, and conveys to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
