TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement") dated as of May 9, 2018 is made by Pacers Basketball, LLC, an Indiana limited liability company ("Granting Party"), in favor of JPMorgan Chase Bank, N.A., as administrative agent for the Secured Parties (as defined in the Security Agreement) (in such capacity, together with its successors and assigns, the "Administrative Agent"). Capitalized terms used but not defined herein shall have the meanings set forth in the Credit Agreement (as hereinafter defined).

PRELIMINARY STATEMENT:

WHEREAS, Herbert Simon, an individual, and the Herbert Simon Revocable Trust under that certain Restatement of the Herbert Simon Revocable Trust, as amended, modified and/or restated from time to time have executed and delivered that certain Credit Agreement of even date herewith with Administrative Agent and the Lenders party thereto (as amended or restated from time to time the "Credit Agreement");

WHEREAS, as a condition, among others, to the Administrative Agent and the Lenders' obligations to make Loans under the Credit Agreement, the Granting Party executed and delivered that certain Security Agreement of even date herewith (as amended or restated from time to time, the "Security Agreement"); and

WHEREAS, in furtherance of the obligations of the Granting Party under the Security Agreement and Credit Agreement and in order to record the security interest in certain intellectual property of the Granting Party granted to the Administrative Agent therein, the Administrative Agent has required the Granting Party to execute and deliver this Agreement for filing in the United States Patent and Trademark Office.

NOW THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Granting Party hereby agrees with Administrative Agent as follows:

SECTION 1. Grant of Security Interest. As security for the prompt and complete payment and performance in full when due (whether at stated maturity, acceleration or otherwise) of all of the Obligations, Granting Party grants to the Administrative Agent, for the benefit of the Secured Parties, a security interest in and continuing Lien, on its right, title and interest (but not its obligations), whether now held, owned or existing or hereafter acquired or arising, in, to and under all of its United States and foreign trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection with any of the foregoing, all extensions or renewals of any of the foregoing; all of the goodwill of the business connected with the use of and symbolized by the foregoing; the right to sue for past infringement or dilution of any of the foregoing or for any injury to goodwill, and all proceeds of the foregoing, including license royalties, income, payments, claims, damages, and proceeds of suit ("Trademarks"), including but not limited to those U.S. registered trademarks listed on Exhibit A attached hereto and incorporated herein by this reference.

SECTION 2. Governing Document. This Agreement is governed by the Security Agreement to which reference should be made for a full description of the rights and remedies of the Administrative Agent with respect to the Trademarks.

SECTION 3. Governing Law. THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE CONSTRUED IN ACCORDANCE WITH AND BE GOVERNED BY THE LAWS OF THE STATE OF NEW YORK AND BE SUBJECT TO THE PROVISIONS SET FORTH IN SECTION 7.13 OF THE SECURITY AGREEMENT (WHICH SECTION 7.13 IS INCORPORATED HEREIN BY THIS REFERENCE, MUTATIS MUTANDIS, AS THOUGH FULLY SET FORTH HEREIN).

SECTION 4. NBA Consent Letter and the CIB Agreement. Each of the provisions of this Agreement shall be subject to the provisions of the NBA Consent Letter and the CIB Agreement, which the Loan Parties, the Administrative Agent and the Secured Parties have accepted as reasonable and appropriate. Without limiting the generality of the preceding sentence, none of the Administrative Agent, the Lenders or the other Secured Parties shall exercise, enforce or attempt to exercise or enforce any of their rights or remedies under this Agreement or any other Loan Document except in accordance with and subject to the NBA Consent Letter. In the event of any inconsistency or conflict between any term or provision of this Agreement or any other Loan Document and the terms and provisions of the NBA Consent Letter or the CIB Agreement, the terms and provisions of the NBA Consent Letter or the CIB Agreement, as applicable, shall control.


