WHEREAS, in connection with the full satisfaction of all of the Release Conditions set forth in the Security Agreement, the Grantors have requested that the Agent execute and deliver this Release to evidence the release of the Agent's security interest in and to the Trademark Collateral and effect the termination of the Trademark Security Agreement.

- 3. <u>Termination</u>. The Agent, without representation or warranty of any kind, hereby absolutely, unconditionally and irrevocably terminates and cancels the Trademark Security Agreement.
- 4. <u>Further Assurances</u>. The Agent agrees to take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including,

without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

- 5. <u>Governing Law.</u> This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
