ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT

This ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT ("Assignment"), dated as of January 19, 2018, is between U.S. BANK TRUSTEES LIMITED (as the current and resigning collateral agent, the "Resigning Security Agent") and GLAS TRUST CORPORATION LIMITED (as the successor collateral agent, the "Successor Security Agent").

WHEREAS, Heckler & Koch GmbH (the "Grantor") and Resigning Security Agent entered into that certain Trademark Security Agreement, dated as of August 18, 2017, and recorded in the United States Patent and Trademark Office on October 26, 2017 at Reel/Frame No. 6191/0427 (the "Trademark Security Agreement"), pursuant to which the Grantor granted security interest in the intellectual property identified on Exhibit A hereto (the "Subject Trademarks"); and

WHEREAS, pursuant to that certain Deed of Resignation and Appointment of Agent and Security Agent, Resigning Security Agent has assigned to Successor Security Agent all of its rights, remedies, duties and other obligations under, among other documents, the Trademark Security Agreement and to the Subject Trademarks, in each instance, in its capacity as administrative agent and collateral agent, as the case may be.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Resigning Security Agent hereby assigns and transfers to Successor Security Agent, all of its rights, title and interest in and to the Trademark Security Agreement and the Subject Trademarks.



