FULL RELEASE OF SECURITY AGREEMENT

THIS FULL RELEASE OF SECURITY AGREEMENT (this "Release") is made and entered into this 7th day of June, 2018, by U.S. BANK NATIONAL ASSOCIATION, a national banking association ("Administrative Agent") as administrative agent for itself, the L/C Issuer, the Swing Line Lender and the Lenders from time to time parties to the Loan Agreement (as herein defined), in favor of PACON CORPORATION, a Wisconsin corporation ("Debtor"). Capitalized terms used herein but otherwise not defined shall have the meanings ascribed to them in the Loan Agreement.

WHEREAS, Debtor, Pacon Holding Company, Superior Specialties, LLC, the Administrative Agent, the L/C Issuer, the Swing Line Lender and the Lenders from time to time party thereto entered into that certain Loan Agreement dated as of October 31, 2011 (as amended, the "Loan Agreement");


WHEREAS, Administrative Agent and Debtor entered into that certain Patent and Trademark Security Agreement, dated as of October 31, 2011 (the "Security Agreement"), which was recorded with the United States Patent and Trademark Office on March 6, 2012, at reel and frame number 4731/0166 with respect to trademark registrations and trademark applications, and was recorded with the United States Patent and Trademark Office on March 6, 2012, at reel and frame number 027818/0190 with respect to patents and patent applications, as amended by a certain Amendment to Patent and Trademark Security Agreement, dated as of October 8, 2014 (the "First Amendment"), which was recorded with the United States Patent and Trademark Office on October 22, 2014, at reel and frame number 5385/0904 with respect to trademark registrations and trademark applications, and was recorded with the United States Patent and Trademark Office on October 23, 2014, at reel and frame number 034021/0232 with respect to patents and patent applications, and as further amended by a certain Second Amendment to Patent and Trademark Security Agreement, dated as of October 8, 2014 (the "Second Amendment"), which was recorded with the United States Patent and Trademark Office on January 18, 2018, at reel and frame number 6251/0662 with respect to trademark registrations and trademark applications (collectively, the Security Agreement, the First Amendment and the Second Amendment, the "Grants"); and

WHEREAS, pursuant to the Grants, Debtor granted to Administrative Agent for the benefit of the Secured Creditors (as defined in the Security Agreement) a continuing security interest in and lien on all of the Debtor's right, title and interest in, to and under the Collateral (as defined in the Security Agreement) including but not limited to (a) the Patents (as defined in the Security Agreement), including but not limited to the patents and patent applications described more fully in Schedule A attached hereto and (b) the Trademarks (as defined in the Security Agreement), including but not limited to those trademark registrations and applications described more fully in Schedule B attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and the Secured Creditors (as defined in the Security Agreement), hereby unconditionally and irrevocably releases, cancels and discharges fully all of its lien and continuing security interest in the Collateral. The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.

IN WITNESS WHEREOF, the undersigned has caused this Release to be executed by its duly authorized officer as of the date first set forth above.
