**TRADEMARK ASSIGNMENT AGREEMENT**

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), dated as of September 1, 2017, is entered into by and among THE DOW CHEMICAL COMPANY, a Delaware corporation ("TDCC") and DOW GLOBAL TECHNOLOGIES LLC ("DGTL"), a Delaware limited liability company (TDCC and DGTL, collectively, "Assignor"), and SK Primacor Americas LLC, a Texas limited liability company ("Assignee") (each, a "Party," and collectively, the "Parties").

WHEREAS, TDCC and SK Global Chemical Co., Ltd. have entered into the Sale and Purchase Agreement, dated as of February 1, 2017, as may be amended from time to time (the "Purchase Agreement"; unless otherwise defined herein, capitalized terms shall be used herein as defined in the Purchase Agreement); and

WHEREAS, pursuant to the Purchase Agreement, Assignor desires to assign all of Assignor's right, title and interest in, to and under the trademarks registrations and applications listed on the attached Schedule A (herein defined as "Trademarks") to Assignee, and Assignee desires to acquire all of Assignor's right, title and interest in, to and under the Trademarks.

**TERMS**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Effective as of the Effective Date, Assignor does hereby assign, transfer, convey and deliver to Assignee, and Assignee hereby receives from Assignor, all of Assignor's right, title and interest in, to and under the Trademarks, together with the goodwill associated therewith.

2. Further Action. The Parties shall, and shall cause their respective Affiliates to, use commercially reasonable efforts to take, or cause to be taken, all appropriate action, to do, or cause to be done, all things necessary, proper or advisable under applicable Law, and to execute and deliver such documents and other papers, as may be required to carry out the provisions of this Assignment and consummate and make effective the transactions contemplated by this Assignment including execution of individual assignment documentation for filing with the authorities of each individual country; provided, that, as between the Parties, Assignee shall be responsible for the preparation and filing of such documents and other instruments that may be necessary to record or perfect Assignee's right, title and interest in and to the Trademarks (including, without limitation, with any applicable Governmental Authorities), and for any and all costs, expenses and fees associated therewith.

3. Counterparts. This Assignment may be executed and delivered (including by facsimile or other means of electronic transmission, such as by electronic mail in "pdf" form) in two or more counterparts, and by the different Parties in separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement.

4. Conflict. If there is any conflict between the Purchase Agreement and this Assignment, each of the Purchase Agreement and this Assignment is to be interpreted and construed, if possible, so as to avoid or minimize such conflict, but, to the extent (and only to the extent) of such conflict, the Purchase Agreement shall prevail and control.

5. Governing Law. This Assignment shall be governed by, and construed in accordance with, the Laws of the State of Delaware. The dispute resolution provisions set forth in the Purchase Agreement shall apply to the resolution of disputes hereunder *mutatis mutandis*.

IN WITNESS THEREOF, the Parties have caused this Assignment to be executed as of the date first written above by their respective officers thereunto duly authorized.




