**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "*Termination and Release*") dated as of April 4, 2018, from HEALTHCARE FINANCIAL SOLUTIONS, LLC, as administrative agent (the "*Agent*") pursuant that certain Trademark Security Agreement dated as of January 29, 2016 (the "*Security Agreement*") by SARNOVA HC LLC, a Delaware limited liability company, TRI-ANIM HEALTH SERVICES, INC., a California Corporation, BOUND TREE MEDICAL, LLC, an Ohio limited liability company, and CARDIO PARTNERS, INC. (formerly known as DXE Medical, Inc.), an Ohio corporation (each a "*Grantor*" and collectively, the "*Grantors*") in favor of the Agent.

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement a security interest (the "*Security Interest*") was granted by the Grantors to the Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 29, 2016 at (i) Reel 5719, Frame 0599, (ii) Reel 5719, Frame 0331, (iii) Reel 5719, Frame 0563 and (iv) Reel 5719, Frame 0302; and

WHEREAS, the Grantors have requested and the Agent has agreed to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications set forth on Schedule I hereto.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.
