Letter of Assignment of Intellectual Property Rights

RGN-BSuites Holdings, LLC (the "Assignor") is the legal and beneficial owner of the Intellectual Property Rights as defined in this Letter. The Assignor agrees to assign to Pathway IP SARL (the "Assignee") the Intellectual Property Rights on the terms of this Letter.

For the purposes of this Letter, "Intellectual Property Rights" shall mean all patents, supplementary protection certificates, petty patents, utility models, rights to inventions, copyright and related rights, trade marks and service marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off and unfair competition, rights in designs, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered and including all applications for (and rights to apply for and be granted), renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world owned by the Assignor, including without limitation those as detailed in the Schedule to this letter.


In consideration of the sum of \$1 (one dollar) (receipt and sufficiency of which the Assignee and the Assignor expressly acknowledge), the Assignor hereby assigns and transfers to the Assignee absolutely with full title guarantee all its right, title and interest (both legal and beneficial) in and to the Intellectual Property Rights, all with effect from the date of this Letter.

All payments made by the Assignee under this Letter are exclusive of VAT. If any such payment constitutes the whole or any part of the consideration for a taxable or deemed taxable supply by the Assignor the Assignee shall increase that payment by an amount equal to the VAT which is chargeable in respect of the taxable or deemed taxable supply, provided that the Assignor shall have delivered a valid VAT invoice in respect of such VAT to the Assignee.


The Assignor shall, at its own cost, perform all further acts and things, and execute and deliver all further documents required by law or which the Assignee requests, to vest in the Assignee the full benefit of the right, title and interest to the Assignee in this Letter, including registration of the Assignee as applicant or proprietor of the Intellectual Property Rights and assisting the Assignee in obtaining, defending and enforcing the Intellectual Property Rights and assisting with any other

proceedings which may be brought by or against the Assignee against or by any third party relating to the Intellectual Property Rights.

This Letter and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of Luxembourg.
