RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of July 2, 2018 (“Effective Date”) by **CITY NATIONAL BANK**, a national banking association, as the arranger and administrative agent for the Lenders, as such term is defined in the below defined Loan Agreement (in such capacity, “Grantee”), in favor of **SV HOLDCO, LLC**, a Delaware limited liability company (“Parent”), **SCREENVISION, LLC**, a Delaware limited liability company (formerly known as **TECHNICOLOR CINEMA ADVERTISING, LLC**) (“OpCo”), **SCREENVISION EXHIBITION, INC.**, a Delaware corporation (“Screenvision Exhibition”); and **SCREENVISION DIRECT, INC.**, a New York corporation (“Screenvision Direct”; Screenvision Direct, together with Parent, OpCo, and Screenvision Exhibition, each individually, a “Grantor”, and individually and collectively, jointly and severally, the “Grantors”).

WHEREAS, reference is made to that certain Amended and Restated Loan and Security Agreement dated as of December 21, 2015 (as amended, restated, supplemented, or otherwise modified from time to time, the “Loan and Security Agreement”), by and among the lenders identified on the signature pages thereof, Grantors and Grantee;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of October 14, 2010 (as amended by that certain Amendment Number One to Trademark Security Agreement, dated as of September 23, 2011, that certain Amendment Number Two to Security Agreement, dated as of December 21, 2015, and as further amended, restated, supplemented, or otherwise modified from time to time, the “Trademark Security Agreement”), to which Grantors and Grantee are a party, Grantors granted to Grantee a security interest in all of Grantors’ right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement);

WHEREAS, (a) the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 4, 2010 at Reel 4409, Frame 0892, (b) Amendment Number One to Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 28, 2011 at Reel 4632, Frame 0081, and (c) Amendment Number Two to Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 22, 2015 at Reel 5696, Frame 0011; and

WHEREAS, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby on behalf of itself and the Lender Group and Bank Product Providers, covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges all liens and security interests in the Trademark Collateral granted pursuant to the Trademark Documents, and reassigns, re-transfers, and re-conveys to Grantors all right, title, and interest, the Grantee may have in, to our under the Trademark Collateral, together with the goodwill of the business symbolized thereby.

2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors’ expense, as may be reasonably necessary to relinquish and effect the release of such liens and security interests in the Trademark Collateral.

3. This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
