**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT (the “Release”) is made as of May 30, 2018, by GENERAL ELECTRIC COMPANY, as successor in interest to General Electric Capital Corporation, as administrative agent (“Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Accolade Wines North America, Inc. and Accolade Wines Australia Limited (individually and collectively, “Grantor”) and Agent are parties to that certain Trademark Security Agreement dated as of June 1, 2012 (the “Security Agreement”) pursuant to which the Grantor granted to Agent a Lien on and security interest in, to and under the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to the Secured Parties;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 14, 2012, at Reel 4801, Frame 0595 and at Reel 4801, Frame 0655;

WHEREAS, Grantor has requested that Agent release its Lien in the Trademarks and Trademark Collateral and reassign any and all rights in the same to the applicable Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its Lien on and security interest in, to and under all of Grantor’s right, title and interest in and to the following (collectively the “Trademark Collateral”):

- (a) all of its Trademarks referred to on Schedule 1 hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.


