## ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (the "ASSIGNMENT") is made as of June 15, 2016, by and between NATIONAL BEEF CALIFORNIA, LP, a Delaware limited partnership ("NBC") and National Beef Packing Company, LLC, a Delaware limited liability company ("NBP," and collectively with NBC hereinafter referred to as "ASSIGNOR"), having a principal place of business at 12200 North Ambassador Drive, Suite 500, Kansas City, Missouri 64163, and OWB REAL ESTATE HOLDINGS, LLC, a California limited liability company, having its principal place of business at 6363 Knott Ave., Buena Park, California 90620, (hereinafter referred to as "ASSIGNEE"),

A. WHEREAS, NBC and ASSIGNEE'S predecessor-in-interest previously entered into that certain Purchase and Sale Agreement and Joint Escrow Instructions dated as of October 7, 2015, as amended by that certain First Amendment to Purchase and Sale Agreement and Joint Escrow Instructions, dated March 29, 2016 (collectively, the "PURCHASE AGREEMENT"), wherein NBC agreed to sell, and ASSIGNEE agreed to purchase, that certain real property located in the City of Brawley, County of Imperial, State of California, as more particularly described in the PURCHASE AGREEMENT (the "PROPERTY"). NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby assigns unto the said ASSIGNEE, all right, title and interest in and to the said MARKS, corresponding U.S. Trademark Applications and/or U.S. Trademark Registrations, together with the goodwill of the business symbolized by the MARKS.

ASSIGNOR agrees to cooperate reasonably, at no cost to ASSIGNOR, in the event ASSIGNEE desires to revive any of the U.S. Trademark Applications and/or U.S. Trademark Registrations listed in Exhibit A, and ASSIGNOR confirms that ASSIGNOR does not have any objections to ASSIGNEE reviving any of the U.S. Trademark Applications and/or U.S. Trademark Registrations listed in Exhibit A, nor any interests therein.


