I

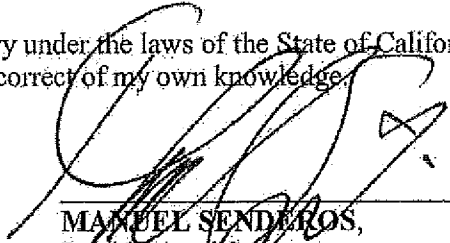
The name of this corporation is AN USA.
