## RELEASE OF SECURITY INTEREST IN TRADEMARKS



The Secured Party further agrees to execute and deliver to Grantor any and all further documents and instruments, and to do all further acts which Grantor (or its agents or designees) reasonably request (at Grantor’s sole cost and expense) to confirm this Release of Security Interest in Trademarks and Grantor’s right, title and interest in and to the Released Trademarks.

This Release of Security Interest in Trademarks shall be governed by and construed in accordance with the laws of the State of New York as applied to agreements among parties resident therein.
