**NOTICE OF RELEASE  
OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**

This **NOTICE OF RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS** (“Notice of Release”), effective as of July 10, 2018, is made by **GOLUB CAPITAL LLC**, a Delaware limited liability company, as Administrative Agent. Unless otherwise expressly indicated, all capitalized terms used, but not defined, in this Notice of Release have the meanings indicated in the Patent and Trademark Security Agreement (as defined below).

**WHEREAS**, CHS Health Services, LLC, a Delaware limited liability company (“CHS”), Premise Health Systems, Inc., a Delaware corporation (“PHS,” formerly known as Take Care Health Systems, Inc.), and Premise Health Employer Solutions, LLC, a Delaware limited liability company (“PHES,” formerly known as Take Care Employer Solutions, LLC, and, together with CHS and PHS, collectively, the “Grantors”), made that certain Patent and Trademark Security Agreement, dated as of June 25, 2014, which was recorded in the records of the United States Patent and Trademark Office (“USPTO”) on July 9, 2014, at Reel 5319, Frame 0302 and at Reel 5319, Frame 0314 (as amended, restated, supplemented, or otherwise modified from time to time, the “Patent and Trademark Security Agreement”), whereby each Grantor granted to Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in all of such Grantor’s right, title and interest in, to and under the Trademark Collateral and the Patent Collateral, including, without limitation, each patent and trademark listed on Schedule A attached hereto; and

**WHEREAS**, Administrative Agent has agreed to release the Patent and Trademark Security Agreement and the security interests and liens on the Patent Collateral and Trademark Collateral granted to Administrative Agent pursuant thereto.

**NOW, THEREFORE**, Administrative Agent hereby agrees as follows:

1. **Release of Security Interest.** For valuable consideration, Administrative Agent hereby terminates, discharges and releases the Patent and Trademark Security Agreement and any and all mortgages, liens and security interests in the Patent Collateral and Trademark Collateral granted to Administrative Agent pursuant to the Patent and Trademark Security Agreement, in each case without representation, warranty or recourse of any kind, and any right, title or interest of Administrative Agent in such Patent Collateral and Trademark Collateral pursuant to the Patent and Trademark Security Agreement shall hereby cease and become void.

2. **Authorization.** Administrative Agent authorizes this Notice of Release to be recorded with the USPTO.




