NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:



2. Assignor agrees to execute such further papers and do such other acts as may be necessary and proper to vest full title in and to the Trademarks in the Assignee or which may be necessary to obtain, renew, issue or enforce the Trademarks.
