**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the “Release”), dated as of July 11, 2018, is made by NATIXIS, NEW YORK BRANCH, as Administrative Agent and Collateral Agent (in such capacity and together with its successors and permitted assigns, the “Collateral Agent”) in favor of TOLT SOLUTIONS, INC., a Delaware corporation and POMEROY IT SOLUTIONS SALES COMPANY, INC., a Delaware corporation (collectively, the “Grantors”).

**WITNESSETH**

WHEREAS, the Grantors and the Collateral Agent entered into that certain First Lien Security Agreement, dated as of November 30, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantors executed the First Lien Trademark Security Agreement dated as of November 30, 2015 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office on December 1, 2015 at Reel/Frame Nos. 5678/0767 and 5678/0474, pursuant to which the Grantors granted to the Collateral Agent a security interest in all right, title or interest in or to any and all of the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in all right, title or interest in, to and under the Trademark Collateral.

NOW, THEREFORE, the Collateral Agent hereby (a) DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty of any kind or nature, any and all security interest, liens, right, title and interest of Collateral Agent in and to all of the Trademark Collateral, including, without limitation, the trademark registrations and applications set forth in **Schedule I** attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released, (b) terminates the Trademark Security Agreement, and (c) authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty of any kind or nature, any and all right, title and interest that the Collateral Agent may have obtained in and to all of its Trademark Collateral under the Security Agreement and the Trademark Security Agreement.


