## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of July 12, 2018 by **SILICON VALLEY BANK**, in its capacity as collateral agent for the Secured Parties (the “*Collateral Agent*”) in favor of **UPSERVE, INC.**, a Delaware corporation (the “*Pledgor*”);

**WHEREAS**, the Pledgor executed and delivered a Trademark Security Agreement, dated as of July 14, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Trademark Security Agreement*”), granting the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), notice of which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on July 14, 2017, at Reel 6122, Frame 0515;

**WHEREAS**, Pledgor has requested that Collateral Agent hereby terminate, release and discharge fully its security interests in and liens on all such Trademark Collateral as herein provided; and

**WHEREAS**, Pledgor has requested that the Collateral Agent provide a document suitable for recording with the USPTO to evidence the release of the Collateral Agent’s security interests in and liens on the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby:

1. terminates the Agreement and releases, terminates and discharges all liens and security interests in Pledgor’s right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
