

Assignment of Intellectual Property Rights

This Assignment of Intellectual Property Rights (this "<u>Assignment</u>") is made and entered into as of May 9, 2018 by and between Loud Audio, LLC, a Delaware limited liability company ("<u>Seller</u>"), and Yamaha Guitar Group, Inc., a California corporation ("<u>Buyer</u>").

Seller does hereby convey, transfer, assign and deliver absolutely and forever to Buyer all of Seller's right, title and interest of every kind and nature in and to the Business Owned Intellectual Property, including without limitation (i) the intellectual property set forth on Schedule A, (ii) the right to apply for new registrations for the Business Owned Intellectual Property, (iii) the right to prosecute, maintain, enforce, use and otherwise exploit Business Owned Intellectual Property, (iv) all income, royalties, damages, and payments hereafter due or payable to Seller with respect to the Business Owned Intellectual Property, including without limitation the right to sue for past, present or future infringement, misappropriation or dilution of any of the Business Owned Intellectual Property or the associated goodwill, (v) all good will of the Business associated with the Business Owned Intellectual Property, and (vi) all rights in and under the Business Owned Intellectual Property to the fullest extent allowed by law as fully as Seller would have held the same in the absence of this Assignment.
- Seller hereby requests the Commissioner of Patents and Trademarks, the U.S. Copyright Office, and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Buyer as the owner of the patents, trademarks, copyrights, or other Business Owned Intellectual Property (as applicable) transferred to Buyer hereunder, and to issue any and all patents, trademarks, copyrights or other Business Owned Intellectual Property (as applicable) transferred to Buyer hereunder to Buyer, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Buyer, its successors, assigns or other legal representatives. Seller hereby covenants and agrees that, at any time and from time to time forthwith upon the written request of Buyer, Seller shall (i) use commercially reasonable efforts to take, or cause to be taken, all actions and to do, or cause to be done, all things necessary, proper or advisable to consummate and make effective the transactions contemplated by this Assignment, (ii) execute any documents, deeds, assignments (including short-form assignment agreements for purposes of recordation), transfers, assurances, instruments or conveyances of any kind which may be reasonably necessary or advisable to convey, transfer, assign and deliver unto and vest in Buyer title to all of Seller's right in and to the Business Owned Intellectual Property, and (iii) cooperate with each other in connection with the foregoing.

- 4. This Assignment is subject in all respects to the terms and conditions of the Agreement and is intended only to document the assignment of the Business Owned Intellectual Property. Nothing contained in this Assignment shall be deemed to supersede any of the obligations, agreements, representations, covenants or warranties of Seller and Buyer contained in the Agreement.
- 5. This Assignment (and any claim or controversy arising out of or relating to this Assignment) shall be governed by the law of the State of New York without regard to conflict of law principles that would result in the application of any law other than the law of the State of New York.
- 6. This Assignment may be executed in one or more counterparts, each of which when executed shall be deemed an original and all of which together shall constitute one and the same instrument. The parties agree that this Assignment shall be legally binding upon the electronic transmission, including by facsimile or email, by each party of a signed signature page to this Assignment to the other party.
