NOTICE OF SECURITY INTEREST IN TRADEMARKS

A. The Grantor has executed a Security Agreement dated of even date herewith in favor of the Bank (as it may be amended, restated, modified, or supplemented from time to time, the "Security Agreement"); and

B. The Grantor changed its name from Triton Acquisition, LLC to Triton Trailers, LLC on March 28, 2013, and although the United States Patent and Trademark Office ("USPTO") lists Triton Acquisition, LLC as the owner of the Trademark (as defined below), the proper name of the owner is now Triton Trailers, LLC due to the aforementioned name change.

C. Pursuant to the Security Agreement, Grantor has granted to the Bank a security interest in and to all of the trademarks, service marks, applications therefor and associated goodwill therein, now owned or from time to time after the date hereof owned or acquired by the Grantor, including without limitation the registrations issued by, and the applications with, the USPTO listed on Schedule A attached hereto (the "Trademark"), and in and to all proceeds and benefits thereof.
