RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property (this “Release”) is effective as of July 12, 2018, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent (in such capacity, “Agent”) in favor of CIS GLOBAL LLC, an Arizona limited liability company, as successor by merger to GCP CIS Intermediate Holdings, LLC, a Delaware limited liability company (the “Grantor”). All terms not herein defined, have the meanings set forth in the Security Agreement referenced below.

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of May 7, 2015, (the “Security Agreement”), Grantor granted to Agent, among other Intellectual Property Collateral (as defined therein), a continuing security interest in and continuing lien upon all of the Grantor’s right, title and interest to the patents and trademarks listed on Exhibit A hereto (collectively, the “Intellectual Property”); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on May 13, 2015 at Reel/Frame 5514/0974.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, Agent hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Intellectual Property Collateral, including the Intellectual Property set forth on Exhibit A, without any recourse, representation or warranty, (ii) re-assigns to Grantor, any right, title or interest the Agent may have in, to or under the Intellectual Property Collateral, including the Intellectual Property set forth on Exhibit A, together with the goodwill of the business symbolized thereby, and hereby authorizes Grantor or their authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination, and (iii) agrees to execute and deliver any other documents and take any further action, in each case at Grantor’s sole expense, which is reasonably requested by any Grantor and is necessary to effect the intent and purpose of this Release.
