ARTICLES OF CONVERSION
OF BASYS INC.,
A MARYLAND CORPORATION
INTO BASYS LLC,
A MARYLAND LIMITED LIABILITY COMPANY

July 2, 2018

Basys Inc., a Maryland corporation, hereby certifies to the State Department of Assessments and Taxation of Maryland (the "Department") that:

1. Basys Inc., a Maryland corporation (the "Converting Company") proposes to convert into a Maryland limited liability company (the "Conversion").
2. The name of the Converting Company immediately prior to filing these Articles of Conversion is "Basys Inc." The original articles of incorporation of the Converting Company were filed with the Department on September 24, 1992.
3. Upon the Conversion, the Converting Company shall convert to a Maryland limited liability company and its name shall be "Basys LLC" (the "Surviving Company").
4. The Conversion of the Converting Company into the Surviving Company has been approved in the manner prescribed by Title 3, Subtitle 9 of the Maryland Corporations and Associations Code, including § 3-902 thereof, and Title 4A, Subtitle 11 of the Maryland Corporations and Associations Code, including § 4A-1102 thereof.
5. Each share of common stock of the Converting Company shall be converted into one (1) unit of membership interest in the Surviving Company, resulting in the entire shareholding of the Converting Company being converted into membership interests in the Surviving Company.
6. These Articles of Conversion (the "Articles") shall be effective as of the time the Department accepts these Articles for record (the "Effective Time").


