**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS –
SECOND LIEN NOTE**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS – SECOND LIEN NOTE, dated as of July 12, 2018, is from WILMINGTON TRUST, NATIONAL ASSOCIATION, as Collateral Agent (the “Collateral Agent”) to HIRERIGHT, LLC (f/k/a HireRight, Inc.), a Delaware limited liability company (the “Grantor”).

WITNESSETH:

WHEREAS, pursuant to the Senior Secured Second Lien Note Collateral Agreement, dated as of July 3, 2014, among Corporate Risk Holdings, LLC (as successor-in-interest to Altegrity, Inc., the “Company”), the subsidiaries of the Company party thereto, and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), HireRight, Inc., a Delaware corporation, granted a security interest to the Collateral Agent in certain collateral;

WHEREAS, pursuant to that certain Notice and Confirmation of Grant of Security Interest in Trademarks – Second Lien Note, dated as of July 3, 2014, among the Collateral Agent and HireRight, Inc. (the “Trademark Security Agreement”), HireRight, Inc., by reference to the Security Agreement, granted a security interest to the Collateral Agent in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by HireRight, Inc. and wherever located or in which HireRight, Inc. now has or at any time in the future may acquire any right, title or interest: (a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, then existing or thereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office (or any successor office) or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed in Schedule I hereto; (b) all extensions or renewals of any of the foregoing; (c) all goodwill associated therewith or symbolized thereby; (d) all other assets, rights and interests that uniquely reflect or embody such goodwill; (e) the right to sue or otherwise recover for any past, present and future infringement or other violation thereof; and (f) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages and proceeds of suit then or thereafter due and/or payable with respect thereto (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 11, 2014 at Reel 5341 and Frame 0483;

WHEREAS, pursuant to that certificate of conversion, dated as of August 25, 2015 and recorded in the Trademark Division of the United States Patent and Trademark Office on August 25, 2015 at Reel 5607 and Frame 0820, HireRight, Inc. converted to the Grantor;

WHEREAS, the Grantor has requested the Collateral Agent terminate and release the entirety of its security interest in the Trademark Collateral;

NOW, THEREFORE, in consideration of the foregoing, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth herein, the Collateral Agent hereby states as follows:

1. Definitions. Capitalized terms used herein and not otherwise defined have the meanings specified in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release of Security Interest. The Collateral Agent hereby (i) terminates, cancels, releases, and discharges, without recourse, representation, or warranty, any and all security interest it has in or to the Trademark Collateral, including under the Security Agreement and the Trademark Security Agreement, and (ii) reassigns any and all such right, title, and interest (if any) that the Collateral Agent may have in the Trademark Collateral to the Grantor. Any right, title, or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Collateral Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by the Grantor to effect the termination and release of the security interest contemplated hereby.
