TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of July 12, 2018, is from CERBERUS BUSINESS FINANCE, LLC, as Collateral Agent (the "Collateral Agent") to CORPORATE RISK HOLDINGS, LLC, (f/k/a ALTEGRITY, LLC), a Delaware limited liability company, HIRERIGHT, LLC, a Delaware limited liability company, and NATIONAL DIAGNOSTICS, LLC, a North Carolina limited liability (each a "Grantor" and collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement Guarantee and Collateral Agreement, dated as of August 31, 2015, among Altegrity Acquisition, LLC, a Delaware limited liability company, Altegrity, LLC, a Delaware limited liability company (the "Borrower"), the subsidiaries of the Borrower party thereto, and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Grantors granted a security interest to the Collateral Agent in certain collateral;

WHEREAS, pursuant to that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of August 31, 2015, among the Collateral Agent and the Grantors and certain other grantors (the "Trademark Security Agreement"), the Grantors, by reference to the Security Agreement, reaffirmed their intent to grant a security interest to the Collateral Agent in the Grantor's Trademark Collateral (as that term is defined in the Trademark Security Agreement), including the Trademark Collateral listed in Schedule I hereto (collectively, the "Released Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 31, 2015 at Reel 5612 and Frame 0645;

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its security interest in the Released Collateral;

NOW, THEREFORE, in consideration of the foregoing, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth herein, the Collateral Agent hereby states as follows:

1. Definitions. Capitalized terms used herein and not otherwise defined have the meanings specified in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release of Security Interest. The Collateral Agent hereby (i) terminates, cancels, releases, and discharges, without recourse, representation, or warranty, any and all security interest it has in or to the Released Collateral, including under the Security Agreement and the Trademark Security Agreement, and (ii) reassigns any and all such right, title, and interest (if any) that the Collateral Agent may have in the Released Collateral to the Grantors. Any right,

title, or interest of the Collateral Agent in such Released Collateral shall hereby cease and become void.

3. Further Assurances. The Collateral Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by the Grantor to effect the termination and release of the security interest contemplated hereby.
