**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is dated as of July 9, 2018 by JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Administrative Agent"), in favor of MELLANOX TECHNOLOGIES, LTD., MELLANOX TECHNOLOGIES TLV LTD., and MELLANOX TECHNOLOGIES SILICON PHOTONICS INC. (each a "Grantor" and collectively, the "Grantors").

WITNESSETH

WHEREAS, Mellanox Technologies, Ltd. and Mellanox Technologies, Inc. (the "Borrowers") and the Administrative Agent entered into that certain Credit Agreement dated as of February 22, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and that certain Collateral Agreement dated as of February 22, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement");

WHEREAS, pursuant to the Collateral Agreement, the Grantors executed and delivered to the Administrative Agent the Trademark Security Agreement dated as of February 22, 2016 (the "Trademark Security Agreement") and recorded with the USPTO on February 24, 2016 at Reel/Frame Nos. 5738/0392, pursuant to which, as a security for the payment in full of the Obligations, each Grantor granted to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties (as defined in the Credit Agreement or the Collateral Agreement, as applicable), a security interest in all right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement); and


WHEREAS, in connection with the payoff of the obligations secured by the Trademark Collateral, the Grantors have requested that the Administrative Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, any and all of the Administrative Agent's security interest in all right, title and interest in, to and under the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference (the "Released Collateral"), and agrees that the Administrative Agent's security interest in the Released Collateral is hereby discharged, terminated and released. The Administrative Agent hereby transfers and reassigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Released Collateral under the Trademark Security Agreement, and authorizes, at the Grantors' sole cost and expense, the recordation of this Release by the Commissioner for Trademarks of the United States Patent and Trademark Office and any other applicable governmental body.
