## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “**Termination and Release**”) is granted as of July 13, 2018 by **BANK OF AMERICA, N.A.** (the “**Secured Party**”) in favor of **THE MCCLATCHY COMPANY** (“**Parent**”), **MCCLATCHY MANAGEMENT SERVICES, INC.** (“**MMSI**”) and **MCCLATCHY USA, INC.** (“**MUI**”) (each a “**Grantor**”, and collectively, the “**Grantors**”).

**WHEREAS**, pursuant to that certain Security Agreement, dated as of September 26, 2008, by and among the Secured Party, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “**Security Agreement**”), the Grantors granted to the Secured Party, in its capacity as administrative agent, a security interest in and to certain collateral;

**WHEREAS**, pursuant to the Security Agreement, Parent executed and delivered a Trademark Security Agreement dated as of November 20, 2008 (as amended, modified or supplemented prior to the date hereof, collectively, the “**Parent Trademark Agreement**”), granting the Secured Party a security interest in and lien on certain Trademarks described therein;

**WHEREAS**, pursuant to the Security Agreement, MMSI executed and delivered Trademark Security Agreements dated as of November 20, 2008, February 11, 2010, December 18, 2012 and September 27, 2017 (as amended, modified or supplemented prior to the date hereof, collectively, the “**MMSI Trademark Agreements**”), each granting the Secured Party a security interest in and lien on certain Trademarks described therein;

**WHEREAS**, pursuant to the Security Agreement, MUI executed and delivered a Trademark Security Agreements dated as of November 20, 2008, February 11, 2010, December 18, 2012 and September 27, 2017 (as amended, modified or supplemented prior to the date hereof, collectively, the “**MUI Trademark Agreements**” and, with Parent Trademark Agreement and MMSI Trademark Agreements, the “**Trademark Agreements**”; capitalized terms used but not defined herein shall have the meaning ascribed to them in the Trademark Agreements), each granting the Secured Party a security interest in and lien on certain Trademarks described therein;

**WHEREAS**, the Trademark Agreements that were executed and delivered on November 20, 2008 were recorded in the Assignment Division of the United States Patent and Trademark Office (“**USPTO**”) on December 10, 2008, at (i) Reel 3900, Frame 0566, (ii) Reel 3900, Frame 0590 and (iii) Reel 3900, Frame 0616;

**WHEREAS**, the Trademark Agreements that were executed and delivered on February 11, 2010 were recorded in the Assignment Division of the USPTO on February 26, 2010, at (i) Reel 4157, Frame 0459 and (ii) Reel 4157, Frame 0720;



**WHEREAS**, the Trademark Agreements that were executed and delivered on December 18, 2012 were recorded in the Assignment Division of the USPTO on January 22, 2013, at (i) Reel 4946, Frame 0977 and (ii) Reel 4947, Frame 0001;

**WHEREAS**, the Trademark Agreements that were executed and delivered on September 27, 2017 was recorded in the Assignment Division of the USPTO on September 29, 2017, at Reel 6166, Frame 0169;

**WHEREAS**, the Grantors have requested that the Secured Party hereby terminated, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Trademark Collateral as herein provided; and

**WHEREAS**, the Grantors have requested that the Secured Party provided a document suitable for recording in the USPTO to evidence the release of its security liens on the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby:

1. terminates the Trademark Agreements and releases, terminates and discharges all liens and security interests in and to the Trademark Collateral, and all goodwill associated therewith, including, without limitation, the Trademark Collateral identified in Schedule I hereto;
2. to the extent that the Secured Party has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors;
3. authorizes and requests that this Termination and Release be recorded at the USPTO; and
4. agrees that it shall, and at the Grantors', or the respective successors' or assigns', reasonable request, execute, acknowledge and deliver to the Grantors all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.


