the right to collect damages, profits and costs, both in equity and law, for any infringement or infringements of the Marks, accruing on or before the Effective Date.

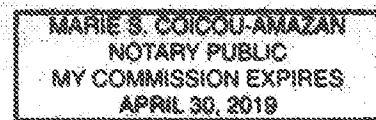


