**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is entered into as of May 18, 2018 (the "Effective Date"), between MANUFACTURERS AND TRADERS TRUST COMPANY, in its capacity as agent (the "Agent"), and FIRST SOURCE, LLC (f/k/a Wythe Will Tzetzko, LLC), a Maryland limited liability company (the "Grantor").

WHEREAS, the Agent, for the benefit of the Lenders, previously was granted a security interest with respect to certain trademarks, as more particularly described in Exhibit A attached hereto, of the Grantor pursuant to an Intellectual Property Security Agreement, dated as of June 28, 2011 (as amended, supplemented, reaffirmed, amended and restated or modified from time to time, the "IP Agreement"; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the IP Agreement), made by Wythe Will Tzetzko, LLC (as predecessor-in-interest to the Grantor), in favor of Agent, which agreement was recorded July 5, 2011 with the United States Patent and Trademark Office at Reel 4575, Frame 0064; and


WHEREAS, in connection with the full satisfaction and discharge of all obligations secured by the IP Agreement, the Grantor has requested that the Agent release its security interest granted pursuant to the IP Agreement in such trademarks and the Agent (acting on behalf of the Lenders) has agreed to do so on the terms and conditions set forth in that certain payoff letter executed by the Agent and the Grantor contemporaneously herewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent (acting on behalf of the Lenders) hereby terminates its security interest and all interests in such trademarks previously assigned to the Agent and all such interests are hereby reassigned to the Grantor without representation or warranty of any kind.



