RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the “Release”), dated as of July 16, 2018, is made by WELLS FARGO BANK, N.A., as collateral agent (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”) in favor of CENTAUR ACQUISITION, LLC, an Indiana limited liability company (the “Grantor”).

WITNESSETH

WHEREAS, the Grantor and the Collateral Agent entered into that certain Pledge and Security Agreement, dated as of June 27, 2014 (the “Pledge and Security Agreement”);

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantor executed that certain (i) Trademark Security Agreement dated as of June 27, 2014 (the “2014 Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office (“USPTO”) on June 30, 2014 at Reel/Frame No. 5311/0522, (ii) Supplement to Trademark Security Agreement dated as of April 28, 2015 (the “2015 Supplement”) and recorded with the USPTO on April 30, 2015 at Reel/Frame No. 5506/0849, and (iii) Supplement to Trademark Security Agreement dated as of April 27, 2016 (the “2016 Supplement”) and collectively with the Trademark Security Agreement and the 2015 Supplement, the “Trademark Security Agreements”) and recorded with the USPTO on May 12, 2016 at Reel/Frame No. 5791/0292, pursuant to which the Grantor granted to the Collateral Agent a security interest in and continuing lien on all of its right, title and interest in, to and under the Trademark Collateral (as defined in the 2014 Trademark Security Agreement and supplemented by the 2015 Supplement and 2016 Supplement); and


WHEREAS, the Grantor has requested that the Collateral Agent, and the Collateral Agent has agreed to, release its security interest in and continuing lien on all of its right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty of any kind or nature, its security interest in and to all of the Trademark Collateral, including the trademark registrations and applications set forth in **Schedule I** attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty of any kind or nature, any and all right, title and interest that the Collateral Agent may have obtained in and to all of its Trademark Collateral under the Pledge and Security Agreement and the Trademark Security Agreements.
