**TERMINATION AND RELEASE  
OF  
PATENT AND TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT** dated as of May 1, 2018, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION (the “Secured Party”), in favor of GATEWAY PACKAGING COMPANY LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms not defined herein shall have the meaning ascribed to them in the Security Agreement (as defined below).

**WHEREAS**, Grantor and the Secured Party entered into a Patent and Trademark Security Agreement, dated as of November 26, 2014 (the “Security Agreement”) which Security Agreement was recorded with the United States Patent and Trademark Office on December 4, 2014, at Reel 5413, Frame 0474 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Credit and Security Agreement (as defined in the Security Agreement);


**WHEREAS**, pursuant to the Security Agreement, the Grantor irrevocably pledged and assigned to the Secured Party, and granted the Secured Party (for the Secured Party as lender and for each Bank Product Provider) a security interest with power of sale to the extent permitted by law in, the Patents and Trademarks (each as defined in the Security Agreement), including, without limitation, the registered Trademarks and applications for Trademarks listed on Exhibit A hereto (the “Intellectual Property”); and

**WHEREAS**, the Secured Party has agreed to terminate and release its security interest in the Intellectual Property as herein provided:

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party’s right, title and interest in and to such Intellectual Property, effective as of the date set forth above.



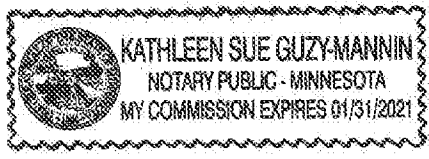
