**RELEASE OF CONFIRMATORY GRANT  
OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made effective as of July 5, 2017, by U.S. BANK NATIONAL ASSOCIATION, a national banking association (the "Secured Party") in favor of CAMPUS BOOK RENTALS, INC., a Delaware corporation (the "Company").

WHEREAS, the Company and the Secured Party are parties to the following agreements, pursuant to which the Secured Party agreed to extend to the Company certain credit accommodations: (a) that certain Loan Agreement dated September 30, 2013, as amended by the First Amendment to Loan Agreement dated October 8, 2014, as further amended by the Second Amendment to Loan Agreement dated September 30, 2015, as further amended by the Third Amendment to Loan Agreement dated March 31, 2016 (as the same may hereafter be further amended, supplemented, extended, restated or otherwise modified from time to time, collectively the "2013 Loan Agreement"); (b) that certain Loan Agreement dated December 23, 2014 (as the same may hereafter be amended, supplemented, extended, restated or otherwise modified from time to time, collectively the "2014 Loan Agreement"); and (c) that certain Loan Agreement dated March 31, 2016;

WHEREAS, the Company granted security interests to the Secured Party under (a) that certain Security Agreement dated September 30, 2013 (as the same may hereafter be amended, supplemented, restated or otherwise modified from time to time, collectively the "2013 Security Agreement"); (b) that certain Security Agreement dated December 23, 2014 (as the same may hereafter be amended, supplemented, restated or otherwise modified from time to time, collectively the "2014 Security Agreement"); (c) that certain Security Agreement dated March 31, 2016 (as the same may hereafter be amended, supplemented, restated or otherwise modified from time to time, collectively the "2016 Security Agreement");

WHEREAS, the Company owns the trademark listed on Exhibit A, which is registered with the United States Patent and Trademark Office (the "Trademark"); and

WHEREAS, the 2013 Security Agreement was recorded with the United States Patent and Trademark office ("PTO") against the Trademark on December 1, 2016, at Reel 5931, Frame 0469;

WHEREAS, the 2014 Security Agreement was recorded with the PTO against the Trademark on December 1, 2016, at Reel 5932, Frame 0001;

WHEREAS, the 2016 Security Agreement was recorded with the PTO against the Trademark on December 1, 2016, at Reel 5931, Frame 0488;

WHEREAS, pursuant to the 2013 Security Agreement, the 2014 Security Agreement, and the 2016 Security Agreement, the Company executed and delivered a Confirmatory Grant of Security Interest in Trademarks dated as of December 2, 2016 (the "Confirmatory Grant") granting the Secured Party, among other collateral as set forth therein, a security interest in and lien on the Trademark;

WHEREAS, the Confirmatory Grant was recorded with the PTO against the Trademark on December 8, 2016, at Reel 5943, Frame 0525; and

WHEREAS, with respect to the Trademark, the Company has satisfied all of its obligations to the Secured Party and has requested that the Secured Party terminate and release all of its security interests in and liens on the Trademark.



1. Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges all of its security interest in and liens on the Trademark listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Company, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to the Trademark, effective as of the date set forth above.
