**WHEREAS**, Bank is the owner of the following:

1. U.S. Reg. No. 4,423,744 for BANK MIDWEST for "banking services" in Class 036; and
2. U.S. Reg. No. 4,228,967 for WHERE COMMON SENSE LIVES for "banking services" in Class 036.


(Collectively, the "Marks").

**WHEREAS**, Bank is desirous of assigning to NBHC the Marks, and NBHC is desirous of acquiring all rights in and to the Marks, including any and all common law rights in and to the Marks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby assigns to NBHC, *nunc pro tunc* as of January 1, 2016, all right, title and interest throughout the world in and to the Marks, together with all of the goodwill of the business symbolized by said Marks, and with the right to recover damages and profits and all other remedies for all past and future infringements thereof.
