The undersigned declares the following:

1. I am an officer of Radio Assets, LLC and have firsthand knowledge of the facts set forth herein.
2. Radio Assets, LLC (a Delaware limited liability company) is the current owner of U.S. Trademark Registration Nos. 1468632 (for the mark WJR), 2612686 (for the mark WYAY), 1465872 (for the mark KSCS), 1440808 (for the mark WKHX), 1587153 (for the mark HOT TALK), and 0548460 (for the mark THE GOODWILL STATION).
