**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This Release of Security Interest in Trademark Rights, dated as of July 19, 2018 (the "Trademark Security Release"), is made by Morgan Stanley Senior Funding, Inc., as the Collateral Agent for the several banks and other financial institutions (the "Lenders") party to the Credit Agreement (as defined below) (in such capacity, the "Agent"), in favor of Edelman Financial Services, LLC, a Delaware limited liability company (the "Grantor"). Capitalized terms used and not defined herein have the meanings given to such terms in the Credit Agreement and the Security Agreement (each, as defined below).

WHEREAS, The Edelman Financial Center, LLC, a Delaware limited liability company (the "Borrower"), certain of its domestic subsidiaries from time to time party thereto, including the Grantor (together, the "Guarantors"), Edelman Financial Holdings IV, LLC, a Delaware limited liability company, and the Agent entered into that certain Credit Agreement, dated as of November 9, 2017, pursuant to which the Lenders severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein (the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, the Grantor and the other Guarantors executed and delivered a Security Agreement, dated as of November 9, 2017, in favor of the Agent (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Agent for the benefit of the Agent and the Lenders a continuing security interest in certain Intellectual Property, including the Trademarks (collectively, the "Trademark Collateral");

WHEREAS, in connection with the Security Agreement, the Grantor executed and delivered that certain Grant of Security Interest in Trademarks agreement dated as of November 9, 2017 made by and between the Grantor and the Agent (the "Trademark Security Agreement") for recording with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on November 9, 2017 on Reel/Frame 6200/0737;

WHEREAS, the Obligations (as defined in the Credit Agreement) secured by the Trademark Collateral have been repaid or otherwise satisfied; and

WHEREAS, the Agent therefore desires to release, terminate and discharge its Lien and security interest in and to the Trademark Collateral and grant all of its right, title and interest in the Trademark Collateral to the Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby releases, terminates and discharges to the Grantor (a) the Agent's continuing security interest in, right of setoff against and Lien on, and (b) any of the Agent's other rights, title or interest of any kind or nature in, to or under, the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule 1 hereto.

2. The Agent hereby authorizes and acknowledges the termination of the Trademark Security Agreement. At Grantor's expense, the Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to

effect the release of the security interest contemplated hereby and terminate the Trademark Security Agreement.

3. This Trademark Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Trademark Security Release by facsimile will be as effective as delivery of a manually executed counterpart of this Trademark Security Release.
