This Assignment may not be modified except in writing and signed by both parties.

3. Binding Effect. This Assignment is binding upon and will inure to the benefit of the parties hereto and their respective heirs, successors and assigns.

4. Governing Law. This Assignment shall be construed and interpreted according to the laws of the State of Alabama, without reference to its conflicts of law provisions.
