RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

(2) upon the request of Grantor or any successor in interest or assignee thereof, and at the expense of Grantor, the Secured Party shall execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by Grantor, or any successor in interest or assignee thereof, to effectuate the release of interests contemplated herein.
