NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has assigned and hereby sells, assigns, transfers and sets over to Assignee, nunc pro tunc as of February 13, 2017, the entire right, title, and interest in and to the Trademarks, and the goodwill of the business connected with the Trademarks, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.


Assignor further assigns to Assignee all right to sue for and receive all damages accruing from past infringement and/or dilution of the Trademarks assigned.


