**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 18, 2018 (“Release”), is made by Five Points Mezzanine Fund III, L.P., a Delaware partnership (“Lender”) in favor of Blazer Interco, Inc., a Delaware corporation, Blake & Pendleton, Inc., a Georgia corporation, and Case Engineering, Inc., a Delaware corporation (each a “Debtor”, and collectively, “Debtors”).

WHEREAS, pursuant to that certain Senior Subordinated Loan and Security Agreement dated as of November 16, 2017 (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Debtors and Lender, and the Trademark Security Agreement dated as of November 16, 2017 by and among the Debtors and Lender (“Trademark Security Agreement”), each Debtor mortgaged and pledged to Lender and granted to Lender a Lien on and security interest in, all of Debtor’s right, title and interest in, to, and under all the Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on November 17, 2017 at Reel 6208 Frame 0307.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Debtors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the Lien on and security interest in all of Debtor’s right, title and interest in, to, and under all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Debtor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Lender has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
