**RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF
TRADEMARK**

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates the Agreement, releases said security interest in and to the Marks, and retransfers and reassigns to the Company, without representation or warranty, all of Agent's right, title and interest in and to the Marks and the goodwill associated therewith.



