**SUPPLEMENT NO. 1  
TO  
TRADEMARK SECURITY AGREEMENT**

July 20, 2018

WHEREAS, pursuant to the terms of that certain Credit Agreement, dated as of October 28, 2015 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among SONOS, INC., a Delaware corporation (the "Grantor"), the other Domestic Borrowers (as defined in the Credit Agreement) party thereto from time to time, SONOS EUROPE B.V., the other European Borrowers (as defined in the Credit Agreement) party thereto from time to time, the Lenders referred to therein, and JPMorgan Chase Bank, N.A., a national banking association, as Administrative Agent (the "Administrative Agent"), the Lenders have agreed to make loans to the Borrowers;

WHEREAS, the Grantor executed and delivered that certain U.S. Pledge and Security Agreement, dated as of October 28, 2015, in favor of the Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "U.S. Pledge and Security Agreement"); capitalized terms not defined herein shall have the meanings provided or provided by reference in the Credit Agreement and the U.S. Pledge and Security Agreement);

WHEREAS, pursuant to the U.S. Pledge and Security Agreement, the Grantor pledged and granted to the Administrative Agent, for the benefit of the Administrative Agent and the Lenders, a continuing security interest in the Trademark Collateral (as defined in the Trademark Security Agreement, defined below);

WHEREAS, the Grantor and the Administrative Agent are parties to that certain Trademark Security Agreement, dated as of October 28, 2015 (as the same may be amended or supplemented from time to time, the "Trademark Security Agreement"), pursuant to which, the Grantor unconditionally granted, collaterally assigned and pledged to the Administrative Agent, on behalf of the Secured Parties, to secure the prompt and complete payment and performance of the Secured Obligations in accordance with the Credit Agreement, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following to the extent constituting Collateral, whether now owned or hereafter acquired or arising: (a) all of its Trademarks including those referred to on Schedule I to the Trademark Security Agreement; (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each License with respect to Trademarks; and (c) all products and proceeds (as that term is defined in the UCC) of the foregoing, including any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, including the right to receive any damages, or (ii) injury to the goodwill associated with any Trademark (but in any case excluding any Excluded Collateral);

WHEREAS, the Grantor has acquired or created additional Trademarks since the date of execution of the Trademark Security Agreement; and

WHEREAS, Schedule I to the Trademark Security Agreement does not reflect all Trademarks acquired or created by the Grantor since the date of execution of the Trademark Security Agreement.

A. The Grantor hereby unconditionally grants, collaterally assigns and pledges to the Administrative Agent, on behalf of the Secured Parties, to secure the prompt and complete payment and performance of the Secured Obligations in accordance with the Credit Agreement, a continuing first priority security interest (subject only to Liens permitted under Section 6.02 of the Credit Agreement) in all of the Grantor's right, title and interest in, to and under the following to the extent constituting Collateral, whether now owned or hereafter acquired or arising (collectively, the "Trademark Collateral"): (a) all of its Trademarks including those added to Schedule I of the Trademark Security Agreement pursuant to paragraph B below; (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each License with respect to Trademarks; and (c) all products and proceeds (as that term is defined in the UCC) of the foregoing, including any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, including the right to receive any damages, or (ii) injury to the goodwill associated with any Trademark. Notwithstanding anything to the contrary herein, in no event shall the Trademark Collateral include any Excluded Collateral.

B. The Trademark Security Agreement is hereby supplemented, effective as of the date hereof, by amending Schedule I thereof so as to add the Trademark listed on Schedule A hereto.

This Supplement No. 1 to Trademark Security Agreement (this "Supplement") has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Administrative Agent on behalf of the Secured Parties in connection with the U.S. Pledge and Security Agreement and is expressly subject to the terms and conditions thereof. The U.S. Pledge and Security Agreement (and all rights and remedies of the Administrative Agent and the Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.

Except as expressly supplemented hereby, the Trademark Security Agreement shall continue in full force and effect in accordance with the provisions thereof on the date hereof. As used in the Trademark Security Agreement, the terms "Agreement," "this Agreement," "this Trademark Security Agreement," "herein," "hereafter," "hereto," "hereof" and words of similar import, shall, unless the context otherwise requires, mean the Trademark Security Agreement as supplemented by this Supplement.

Except as expressly supplemented hereby, the Trademark Security Agreement and all documents contemplated thereby, are each hereby confirmed and ratified by the Grantor.

The execution and filing of this Supplement, and the addition of the Trademarks set forth herein are not intended by the parties to derogate from, or extinguish, any of the Administrative Agent's or any Secured Party's rights or remedies under (i) the Trademark Security Agreement and/or any agreement, amendment or supplement thereto or any other instrument executed by the Grantor and heretofore recorded or submitted for recording in the U.S. Patent and Trademark Office or (ii) any financing statement, continuation statement, deed or charge or other instrument executed by the Grantor and heretofore filed in any state or county in the United States of America or elsewhere.

This Supplement may be executed in any number of counterparts, each of which shall be an original, and all of which, when taken together, shall constitute one agreement. Delivery of an executed signature page of this Supplement by facsimile transmission or electronic mail shall be effective as delivery of a manually executed counterpart hereof.


