**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of July 23, 2018, by **AB PRIVATE CREDIT INVESTORS LLC**, a Delaware limited liability company (the “Administrative Agent”) in favor of **TVC ALBANY, INC.**, a Delaware corporation, **OXFORD COUNTY TELEPHONE AND TELEGRAPH COMPANY**, a Maine corporation, and **BAYRING COMMUNICATIONS, INC.**, a New Hampshire corporation, each with an address at 41 State Street, Albany, New York 12207 (collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain trademark security agreement dated December 22, 2016 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on January 18, 2017 at the United States Patent and Trademark Office at Reel 5969, Frame 0781.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantors granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of their Trademark Collateral, including the Trademarks listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby agrees as follows:

1. The Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, including all goodwill associated with the Trademark Collateral, and assigns, transfers and conveys to Grantors any interest in such intellectual property, including the Security Interest.


2. The Administrative Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Trademark Release.

3. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
