TERMINATION OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“**Agreement**”) is made and executed as of January 2, 2018, by YORK CREDIT OPPORTUNITIES FUND, L.P., a Delaware limited liability company (“**Collateral Agent**”) in favor of HUNDRED ACRE WINE ESTATE, LLC, a California limited liability company (the “**Company**”).

RECITALS

A. The Company and Collateral Agent entered into that certain Security Agreement as of January 23, 2007 (the “**Security Agreement**”) which granted Collateral Agent a security interest in the trademarks set forth on Exhibit A attached hereto (the “**Trademarks**”).

B. The Security Agreement was recorded with the United States Patent and Trademark Office on January 25, 2007, in Reel 003467, Frame 0831-0845.

C. The Company and Collateral Agent now wish to terminate the Security Agreement.

NOW, THEREFORE, in consideration of the mutual agreements contained herein, the parties hereto agree as follows:

AGREEMENT

1. Termination. The Company and the Collateral Agent hereby agree to terminate the Security Agreement as of the date set forth above. The Collateral Agent hereby fully and completely releases its security interest in the Trademarks created by the Security Agreement. The Collateral Agent claims no right, title, or interest in the Trademarks.

2. General Provisions.

2.1. Entire Agreement. This Agreement contains the entire agreement between the parties, and supersedes all prior negotiations, drafts, and other understandings which the parties may have had concerning the subject matter hereof.

2.2. Counterparts. This Agreement may be executed in any number of counterparts, and each such counterpart shall be deemed to be an original instrument. All such counterparts together shall constitute one and the same Agreement.

2.3. Governing Law. This Agreement shall be governed by, and construed in accordance with, the law of the State of California, without giving effect to principles of conflict of laws.

IN WITNESS WHEREOF, the parties have executed this Agreement as of the date set forth above.


