**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination"), is dated as of March 26, 2018, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as agent to Lenders under the below-defined Security Agreement, having an office at 340 Madison Avenue, 11<sup>th</sup> Floor, New York, New York 10173 ("Grantee") to **UNIPOWER, LLC.**, a Delaware limited liability company ("Grantor"), with a principal office at 125 Summer Street, Suite 1840, Boston, MA 02110.

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of March 31, 2015, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Assignment Branch of the Trademark Division of the United States Patent and Trademark Office on April 2, 2015 at Reel 5490 and Frame 0791 and a corrective assignment to correct an incorrect registration number was recorded in the Assignment Branch of the Trademark Division of the United States Patent and Trademark Office on April 10, 2015 at Reel 5549 and Frame 0308;

WHEREAS, the Security Agreement was recorded with the United States Copyright Office on April 6, 2017 at Volume No. 9922 /Document No. 215;

WHEREAS, the Security Agreement was recorded in the Assignment Branch of the Patent Division of the United States Patent and Trademark Office on April 2, 2015 at Reel 035356 and Frame 0703;

WHEREAS, Grantee now desires to terminate and release the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The terms "Lenders," "IP Collateral," "Trademarks," "Copyrights" and "Patents" as used herein, shall have the meanings set forth in the Security Agreement, and furthermore, the IP Collateral subject to this Termination shall also mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the assets listed on Schedule 1 hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges all liens and security interests in the IP Collateral, including all such IP Collateral identified on Schedule 1, effective as of the date hereof.
