## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** (this "Assignment") is effective as of July 25<sup>th</sup>, 2018 ("Effective Date") by ATKINS NORTH AMERICA, INC., a Florida corporation ("Assignor"), to and in favor of ATKINS NUCLEAR SECURED HOLDINGS CORPORATION, a Delaware corporation ("Assignee") having an address at 4030 West Boy Scout Boulevard, Suite 700, Tampa, Florida 33607.

**WHEREAS**, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all of the Assignor's rights, title and interest in and to the ATKINS ENGINEERS mark, including, without limitation, U.S. Trademark Registration No. 4,797,540 for the mark covering use in connection with engineer services, namely, construction project management, and building management in International Class 37; engineer services, namely, structural engineering and design in International Class 42; and litigation support related to construction claims for engineers in International Class 45; related common law and other rights, the benefit of prior use thereof and the goodwill of the business associated therewith and symbolized thereby (collectively, the "Mark").

**NOW, THEREFORE**, for Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Mark, for the United States and elsewhere, including, without limitation, U.S. Trademark Registration No. 4,797,540, all common law rights, the benefit of Assignor's prior use of the Mark, the associated goodwill, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, at least as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby requests the Commissioner for Trademarks to record Assignee as the Assignee and owner of the Mark.

Assignor shall take all further reasonable actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation), requested by Assignee to more fully and effectively effectuate the purposes of this Assignment, provided that none of the foregoing shall be at any cost to the Assignor, unless such reasonable actions are necessary due to some action or omission to act on the part of Assignor.

This Assignment shall be governed by and construed in accordance with the domestic laws of the State of Florida without giving effect to any choice or conflicts of laws provision or rule (whether of the State of Florida or any other jurisdiction) that would cause the application of the laws of any other jurisdiction.

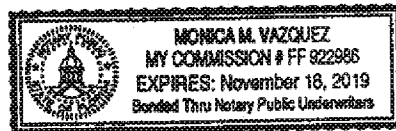
