## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated May 25, 2018 by BMO Harris Bank N.A., a national banking association (“*BMO*”), with its mailing address at 111 West Monroe, Chicago, Illinois 60603 acting as administrative agent hereunder for the Secured Creditors as defined in the Agreement defined below (BMO acting as such administrative agent being hereinafter referred to as the “*Agent*”);

### WITNESSETH:

WHEREAS, each of Rahr Corporation, a Delaware corporation (the “*Rahr*”), with its principal place of business and mailing address at 801 1st Avenue West, Shakopee, Minnesota 55379 and Brewers Supply Group, Inc., a Delaware corporation (the “*Brewers*” and together with Rahr, the “*Debtor*”) with its principal place of business and mailing address at 801 1st Avenue West, Shakopee, Minnesota 55379, and Agent were parties to a certain Trademark Collateral Agreement dated October 2, 2015 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on October 10, 2015 at Reel 005636, Frame 0965 (the “*Agreement*”), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademark Property*”); and

WHEREAS, Debtor has requested that Agent release its security interests in the Trademark Property and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:

(i) each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.






