Pursuant to the provisions of Section 14-2-1105 of the Official Code of Georgia Annotated (the "Code"), the undersigned surviving corporation hereby adopts and files the following certificate of merger:

1. V1 Document Management Inc., a Delaware corporation, and Cedar Group US, Inc., a Massachusetts corporation (each of the foregoing companies a "Disappearing Company" and collectively, the "Disappearing Companies") shall merge with and into Transoft, Inc., a Georgia corporation. Transoft, Inc. shall be the survivor of the merger and will continue operations under the name "OneAdvanced, Inc." (the "Surviving Company").

2. The Articles of Incorporation of Transoft, Inc. will not be amended pursuant to the Agreement and Plan of Merger, except to amend the Articles to change the name of the Survivor to "OneAdvanced, Inc."

3. The executed Agreement and Plan of Merger is on file at the principal place of business of the Surviving Company, located at 1165 Northchase Parkway, Suite 225, Marietta, GA 30067. A copy of the Agreement and Plan of Merger will be furnished, on request and without cost, to any shareholder of the merging corporations.

4. The Agreement and Plan of Merger has been duly authorized and approved by the shareholders of each of the Disappearing Companies and the Surviving Company in accordance with Sections 14-2-1105 and 14-2-1107 of the Code.

5. The Merger shall be effective upon filing with the Secretary of State of Georgia.


