**RELEASE OF SECURITY INTEREST
IN CERTAIN TRADEMARK COLLATERAL**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Madison Capital Funding LLC, in its capacity as agent for certain lenders (in such capacity, "Agent"), does hereby release, relinquish, discharge, and terminate the entire security interest it holds in the Grantor's (as defined herein) right, title and interest in, to and under that certain Trademark Collateral of FOR Franchising, LLC ("Grantor"), granted to Agent pursuant to the Trademark Security Agreement, dated December 13, 2016, by and among Grantor and Agent, which was recorded in the United States Patent and Trademark Office on December 13, 2016, at Reel 5951, Frame 0117 (the "Trademark Security Agreement"; all capitalized terms used herein and not otherwise defined shall have the meanings ascribed to such terms in the Trademark Security Agreement), including but not limited to the registered Trademarks set forth on Exhibit A annexed hereto and made a part hereof, and hereby certifies that the foregoing security interest is hereby released, relinquished and discharged with respect to the Grantor and that any and all right, title and interest in such Trademark Collateral previously assigned to Agent under the Trademark Security Agreement is hereby reassigned to Grantor, without representation or warranty of any kind, nature or description. The Agent hereby authorizes the Grantor, or the Grantor's authorized representatives to record this Release of Security Interest with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Agent agrees to execute and deliver to the Grantor, at the Grantor's expense, all other instruments and other documents as may be reasonably requested or are necessary or proper to release and terminate the security interest in the Trademark Collateral which had been granted under the Trademark Security Agreement.
