TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, David Jackson, an individual, whose address is 41646 Road 62, Reedley, California, 93654 (hereinafter "Assignor"), owns U.S. Trademark Reg. No. 2,877,454 for FAMILY TREE FARMS, registered August 24, 2004 (hereinafter the "Mark"); and,

WHEREAS, Family Tree Farms, Inc., whose address is 41646 Road 62, Reedley, California 93654 (hereinafter "Assignee"), is desirous of acquiring all rights in the Mark and in the '454 Registration, together with the goodwill of the business associated therewith.

NOW, THEREFORE, for good and valuable consideration, the full receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby:

1. Assignor hereby assigns, transfers and conveys to Assignee, Assignor's entire right, title and interest in and to the Mark and the '454 Registration, together with the goodwill of Assignor's business associated therewith;
2. Assignor hereby assigns to Assignee all causes of action, claims and rights to damages or profits, due or accrued, arising out of past infringement of the Mark and the '454 Registration, or injury to the goodwill associated with the Mark and the '454 Registration, as well as the rights to sue for and recover the Mark and the '454 Registration in Assignee's own name; and
3. Assignor represents and warrants that it will reasonably cooperate (i) in any actions necessary for Assignee to prosecute, renew or register its rights, title and interests in and to the Mark and the '454 Registration, including United States and foreign registrations, at Assignee's expense, and (ii) in any actions brought to enforce the rights accompanying this Assignment against third parties, at Assignee's expense.
4. Assignor hereby authorizes and requests the U.S. Patent & Trademark Office to record the assignment of the '454 Registration to Assignee for its sole use, and for the use of its legal representatives and assigns, to the full end of the term for which such registration may be granted, as fully and entirely as the same would have been held by Assignor had this assignment not been made.
