INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this “Agreement”) is entered into as of May 17, 2018 by and among California Cryobank Stem Cell Services, LLC, a California limited liability company (the “Assignee”), Cord Blood America, Inc., a Florida corporation (“CBAI”), and CBA Properties, Inc., a Florida corporation (together with CBAI, the “Assignors”). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Purchase Agreement (as defined hereinafter).

RECITALS

Assignee and CBAI have entered into that certain Asset Purchase Agreement, dated as of February 6, 2018 (the “Purchase Agreement”), pursuant to which CBAI agreed to, and agreed to cause each other Assignor to, sell, assign, convey, transfer and deliver, as applicable, to Assignee, free and clear of all Liens of any kind whatsoever, and Assignee has agreed to purchase and accept from Assignors, all right, title and interest of whatever kind and nature of any Assignor in and to the Acquired Assets, including, without limitation, the Domain Names and Trademarks set forth on Exhibit A (the “Assigned Marks”) on the terms and subject to the conditions set forth in the Purchase Agreement.

In accordance with the terms of the Purchase Agreement, each Assignor and Assignee have agreed to enter into this Agreement to effect the sale, assignment, conveyance, transfer and delivery from each of the Assignors to Assignee of all right, title and interest of whatever kind and nature of any Assignor in and to the Assigned Marks, and the acceptance of such sale, assignment, conveyance, transfer and delivery by Assignee.

NOW, THEREFORE, in consideration of the premises and mutual promises herein made, and in consideration of the representations, warranties and covenants herein contained, the parties agree as follows:

1. Intellectual Property Rights. Each Assignor hereby irrevocably sells, transfers, conveys, assigns and delivers to Assignee, and Assignee hereby accepts, all right, title and interest of whatever kind and nature of such Assignor in and to the Assigned Marks, including (a) all federal, state, foreign, statutory, common law and other rights in and to the Assigned Marks, (b) all domestic and foreign applications and registrations therefor, and all extensions and renewals of such applications and registrations, and the right to apply for any of the foregoing, (c) all goodwill associated with the Assigned Marks and symbolized thereby, (d) all rights to causes of action and remedies related to any of the foregoing, including the right to sue and recover for, and the right to profits and damages due or accrued arising out of or in connection with, any and all past, present or future infringements, misappropriations or violations of, or damage or injury to, any of the foregoing and (e) any and all other rights and interests arising out of, in connection with or in relation to the Assigned Marks. Each Assignor shall immediately discontinue use of the Assigned Marks throughout the world in all forms and media. Each Assignor shall not register or use any Domain Names, Trademarks or service marks that are confusingly similar to any of the Assigned Marks (or any variations, translations or combinations thereof or similar names) anywhere in the world in any form or media.

2. Recordation. Each Assignor hereby requests and authorizes the United States Patent and Trademark Office, the United States Copyright Office and any other applicable Governmental Authority to record Assignee as the owner of the Assigned Marks assigned to Assignee hereunder and issue any and all registrations thereon to Assignee, as assignee of the entire right, title and interest in and to the same for the sole use and enjoyment of Assignee and its successors or other legal representatives. Assignee shall have the right to record this Agreement with all applicable Governmental Authorities so as to perfect its ownership of the Intellectual Property Rights assigned to Assignee hereunder.

3. Conflicts with Purchase Agreement. This Agreement is made pursuant to, and is the subject to the terms of, the Purchase Agreement. Notwithstanding anything to the contrary contained in this Agreement, nothing contained herein shall be deemed to supersede, limit, restrict, expand or modify in any manner the rights, limitations, disclaimers or obligations of the parties under the Agreement, and to the extent there is a conflict between the terms and provisions of this Agreement and the Purchase Agreement, the terms and provisions of the Purchase Agreement will govern.

4. Further Assurances. Each Assignor hereto shall execute and deliver such additional documents, instruments, conveyances and assurances and take such further actions as Assignee may reasonably request to carry out the provisions hereof and give effect to the transactions contemplated by this Agreement.

5. Miscellaneous. Sections 9.1, 9.2, 9.3, 9.4, 9.5, 9.6, 9.7, 9.8, 9.10 and 9.13 of the Purchase Agreement shall apply to this Agreement, *mutatis mutandis*, as if set forth herein.
