ARTICLES OF MERGER OF
TECH SYSTEMS, INC.

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Section 490.1106 of the Iowa Business Corporation Act, Tech Systems, Inc., an Iowa corporation (the "Corporation"), adopts the following Articles of Merger:

1. The Corporation and Integrasoft, Inc., an Iowa corporation, are parties to a merger being effectuated pursuant to a Plan and Agreement of Merger dated the 22nd day of July, 2013 (the "Plan"). Pursuant to the Plan, the Corporation is the survivor of the merger.
2. Pursuant to the Plan, the articles of incorporation of the Corporation are amended in the following respects: Section 1.01 of Article I of the Certificate of Incorporation is amended to read in its entirety as follows: the name of the Corporation is Integrasoft, Inc.
3. The Plan was duly approved by shareholders of the Corporation and by shareholders of Integrasoft, Inc. in the manner required by the Iowa Business Corporation Act and the articles of incorporation of each corporation.


